- 1. What is the main theoretical perspective presented in the text? How relevant is it to explain the current challenges of overpopulation, security, and environmental protection?
- 2. Do you think that environmental factors and climate change in general could be key reasons for future military conflicts?
- 3. In this debate between environmental pessimists and optimists, which side would you take? What are the most appealing arguments from both sides, and which arguments are more arguable in your opinion?

4. Aren't we overestimating the role of technological and social innovations to tackle the challenges mentioned in the essay? How significant will their future contribution be, and what are the risks associated with their uncontrollable implementation?

Start with the abstract and then provide your answers to the questions.

- 1. "In a recent survey of professional economists, the proposition "Some restrictions on the flow of financial capital are essential to the stability and soundness of the international financial system" received about 25% responses "Agree" and about 36% responses "Disagree" (the rest of responses remaining in between). Provide arguments in support of both opposing views, assess their relative strengths and weaknesses, and argue your own position concerning measures of economic policy in this sphere".
- 2. For many decades, rebellious and genocidal Als in the shape of sentient robots or rogue software have been among popular culture's favorite villains. Advances in computer sciences and robotics have not materialized into anything close to a dreadful Skynet or an autonomous cybernetic assassin. Despite massive investments and competing R&D projects attracting many talents from all over the world, artificial general intelligence is nowhere near. Yet, more academics, politicians, activists, and entrepreneurs are raising alarms about the negative consequences of Al-powered technologies in many spheres of life.

You may choose one of the following questions to organize your arguments into an academic essay. You are to substantiate your arguments with something more solid than your common sense.

- (a) When the Al issue is brought into meaningful political, security, ethical, etc. discussions, what should we *really* worry about most? Are the grounds of our current (or recurring) fears and vocal alarms misplaced?
- (b) Can existential threats from the AI be avoided? If these threats are not misplaced, what problems are be solved to avoid extinction from intelligent machines and make them human friendly? You may want to take a political, economic or ethical perspective to answer this question
- 3. What has the global COVID-19 pandemic revealed about advanced (or *if you like* developing) states and societies? *You may want to take a political, economic or philosophical perspective to answer this question.*
- 4. The classic theory of formation of political party systems stipulates that its configuration depends on the salient socio-economic cleavages present in a given society. Do you believe that this theory is appropriate to explain and analyze the current Russian party system? If yes, which cleavages have the most profound impact on its configuration? If no, which factors determine the formation and evolution of the Russian party system?
- 5. The concept of bounded rationality has been a key element of different public policy studies since the 1950s. It is fundamental for understanding the nuances of the policymaking process, but do you think there is a trend in how it is changing over time? Shall we say that decision makers in democratic institutional landscapes have become more (or less) rational in recent years, or does the overall level remain the same? *Provide examples and factual information to support your argument.*
- 6. "Nudging" in public policy is based on the assumption that individuals use mental "shortcuts" in their routine decision-making and that these "shortcuts" do not always serve their best interests. By "nudging," we do not focus on persuading them what action will better serve their long-term welfare. The idea is to design a specific choice environment so that when people use familiar shortcuts, the most reliable option available to them will be one that is likely to serve their own welfare, and that of society more broadly. What ethical and efficacious constraints do you see in relation to this approach in policymaking?
